FORM B/QA Field Inspection Application	\$50 1 st Field, \$10 each additional (up to 2 weeks past due date) \$100 1 st Field, \$10 each additional (over 2 weeks past due date)
Corn Applications	\$25 per field
Production and Disposition Reports	\$10 per field per month past due
